Pledge of Allegiance

Board President Michael Goldberg welcomed those present and announced that the Board of Education was interested in encouraging all members of the public to share their ideas, comments and questions. He noted that public participation opportunities would be available at the beginning of the meeting and again at the end of the meeting and, as stated in Board Policy, no person should speak for more than three minutes and each period of public participation would be limited to thirty minutes. If there were questions or concerns regarding matters on the Consent Agenda, it would be important to utilize the first public participation opportunity as the Board would act on those items immediately. Mr. Goldberg pointed out the emergency exit. The public session began with the Pledge of Allegiance.

Superintendent's Update

Monthly Update

Board President Michael Goldberg introduced Superintendent of Schools Paul Defendini and asked for his monthly update. Mr. Defendini provided details regarding the May 17, 2020 Special Olympics event, which will be hosted at the Howitt Middle School Athletic Complex. He provided an update on the Aquatic Center and the end of National Grid's moratorium on gas service. Finally, he stated that the district's Business Office was in the early stages of building the 2020-2021 budget. Assistant to the Superintendent for Business Michael Motisi and his staff were preparing for the March budget hearings and eventual May 19, 2020 Budget Vote and Election.

Board President Michael Goldberg introduced Assistant Superintendent for Innovation and Organizational Development Dr. William Brennan. Brennan provided an update to the Board of Education on the Farmingdale High School L.A.U.N.C.H. (Learners Accessing Unique New Channels of Help.) Lab, a 2019-2020 initiative that provides learning supports for students across the curricular areas. He, along with Principal Dr. Samuel Thompson, teachers Diana Rossi and Kathleen Danyko and high school students, provided an overview of the development of the program, including feedback received from the Schools of Opportunity Program on building and expanding student supports, allowing for student self-assessment and awareness of educational goals. Mrs. Rossi described the connections and remediation opportunities available to students in a flexible, unbiased multidisciplinary environment. School social workers, deans and school counselors work with students in the lab to provide support in a welcoming environment. LAUNCH leaders are providing informal supports to their peers, assisting with test prep, essay writing, tutoring and social interactions. Dr. Brennan concluded the presentation with a summary of the increasing student engagement and plans for the 2020-2021 school year.
