Call to Order

Meeting called to order at 6:00 p.m. by Mr. Goldberg, President of the Board of Education. In accordance with Governor Cuomo's Executive Order related to temporary modifications to Public Officers Law, the meeting was conducted in a virtual format to allow for the uninterrupted continuation of our important work. The Board meeting notice indicated that access to the meeting would be posted on the district's website at www.farmingdaleschools.org and a live feed would be available on www.youtube.com.

Executive Session

Motion made by Mrs. D'Amico, seconded by Mr. Giordano, to meet in executive session to discuss specific personnel matters in accordance with Open Meetings Law. Motion carried 7-0

Meeting recessed for executive session at 6:00 p.m.

Meeting reconvened in public session at 8:00 p.m. Board President Michael Goldberg opened the meeting with the following statement:

Motion to Suspend Public Participation Pursuant to Executive Order 202.1 (and subsequent orders closing District schools) issued by the Hon. Andrew M. Cuomo, Governor of the State of New York, signed March 12, 2020, and due to the concerns of the Board of Education for the Health and Safety of the community emanating from the current COVID-19 pandemic, there would be no in-person public access to the board meeting and instead the meeting would be live streamed and recorded. Access to the live stream could be had by accessing the school district's website for a link that will bring you to a youtube site and the recording of the meeting can be accessed on www.farmingdaleschools.org. In addition, the public participation portion of the meeting was suspended by board resolution.

On a motion made by Mrs. D'Amico, seconded by Mr. Espinosa, pursuant to the aforementioned Executive Order, the Board suspended the public participation portion

of the meeting and therefore, accordingly, there would be no public participation at this Board meeting.

Pledge of Allegiance

Mr. Goldberg continued, stating that the Board of Education was interested in encouraging members of the public to share their ideas, comments and questions. Feedback and questions should be directed to the Board's email account at boe@farmingdaleschools.org. Questions and comments would be responded to by members of the central administrative team and would be publicly reviewed at the next regular Board meeting. Mr. Goldberg thanked everyone for their anticipated courtesy and cooperation. The meeting began with the Pledge of Allegiance.

Superintendent's Update

Monthly Update

Board President Michael Goldberg introduced Superintendent of Schools Paul Defendini and asked for his monthly update. Mr. Defendini began with his thanks to the staff, students and families of Farmingdale Schools for their flexibility and patience during the past month and holiday season. He explained to the Board of Education that many families chose to flip to remote, virtual learning, just prior to the recess and then again when schools reopened. This temporary measure was set up to provide for instructional opportunities at a time when there were concerns about quarantining during the break. All schools would be working on a remote schedule for two days this week, Thursday and Friday, January 14 and 15, due to an uptick in the number of cases and the number of associated quarantines. Mr. Defendini stated that the school nurses are the unsung heroes in this pandemic as their contact tracing protocols have kept the schools open and the staff and students safe from any unintended spread.

Mr. Defendini spoke specifically about the Howitt Middle School and new opportunities for Grade 6 and 7 students. There would be a realigned hybrid model for families interested in adjusting their student's schedule. Principal Michael Gavalas and Assistant to the Superintendent Jennifer Olsen presented information in a virtual Town Hall meeting to allow parents to make an informed choice.

On the athletic field, Section 8 has approved the opportunity for low contact sports for the winter season. More information would be forthcoming from that body's executive board.

Mr. Defendini concluded his update with a statement that summed up his admiration and awe of the students and staff who continually "show up". He stated that he has spoken of his thanks to every member of the Farmingdale Schools team for their efforts in supporting students and supporting our instructional programs. Even during the biggest challenges, whether they are at the local or national level, employees show up, virtual learning continues, support staff provide for student wellbeing, operations staff keep the school environment safe and clean, food service staff feed us and nurses provide care to those in need. We are all fighting to do what is best for our students. He thanked everyone, once again, for the work that they do.

Board President Goldberg thanked Mr. Defendini. He was particularly grateful for the work of the administrative team, in addition to all of the members of the school community. Mr. Goldberg stated that all have done an extraordinary job.,

The Safety Committee is focusing its efforts on all things COVID and safety drills. The Legislative Action Committee is working on its annual listing of priorities. Visits with elected officials are being scheduled. The group met with Senator Brooks.

Mrs. Lively also reported on the work of the Farmingdale Youth Council. She announced that information on the organization's two scholarships could be found on their website or in the High School Guidance Office. Application deadlines are March 15.

Mr. Goldberg stated that the Massapequa/Farmingdale Mens' Club would also be offering a scholarship this year.

Board President Michael Goldberg introduced Assistant Superintendent for Human Resources and Administration Glen Zakian, who presented the 2021-2022 draft school calendar.

Mr. Zakian walked through the draft calendar, explaining that the Labor Day and Rosh Hashanah holidays occur over the first weekend of September. As such, teachers would return to work for their conference days on September 1 and 2nd; Labor Day would be celebrated on September6 and Rosh Hashanah would be on September 7th and 8th, Students would return for the first day of school on Thursday, September 9. Mr. Zakian stated that a new holiday was added to this calendar to commemorate Juneteenth: schools would be closed on June 20. He concluded with a review of the SED required 180 student contact days and the required 183 teacher work days. Adjustments, if any, to the calendar would be the result of school closures for snow or other events. Make up days are built in to the Memorial Day weekend and the spring recess.

Mr. Goldberg thanked Mr. Zakian for his efforts as the calendar did present some challenges this year.
