Draft Policy #1800, Gifts from the Public

#### DRAFT #1800

#### GIFTS FROM THE PUBLIC

The Board of Education may accept, on behalf of and for the school district, any bequest or gift of money or property provided it is made within the statutory authority granted to school districts and has received the approval of the Board.

All gifts made to the schools or the district, including solicitations made through online fundraising websites (e.g., GoFundMe, YouCaring, DonorsChoose, etc.), become the property of the Board and are considered gifts to the district as a whole and not to a particular school.

The appropriate use of all donations will be the sole responsibility of the Board of Education.

The final determination as to whether a gift will be accepted is within the discretion of the Board of Education. Therefore, a prospective donor should consult with administration prior to raising funds, obtaining gifts or making a donation to discuss any issues presented, including, but not limited to the fact that under some circumstances, in order to effectuate the purpose of a donation, advance planning by administration will be necessary. Donations should be made a sufficient period of time in advance in order to enable the District to properly evaluate and plan the implementation of same.

As is aforementioned, the Board of Education reserves its right to accept and/or reject any gift. However, the Board provides the following guidelines, that gifts to the District:

- 1. Will have a purpose consistent with Board rules, regulations and policies;
- 2. Will not require additional staff;
- 3. Will not be accepted if the Board is obliged to assume continuing program, staffing or financial responsibility when the gift or grant funds are exhausted;
- 4. Will neither place restrictions on the school programs nor be inappropriate, inequitable or harmful to the best education of the students;
- 5. Will not result in undesirable or hidden costs to the school system;
- 6. Will only be accepted under circumstances deemed appropriate by the Board;
- 7. Will be offered by a donor acceptable to the Board:
- 8. Must not benefit a particular or named individual or individuals;
- 9. Will not be in conflict with any provisions of public law;
- 10. Shall be formally approved by the Board at a public meeting.

If the purpose of the gift is an award or scholarship to a single unnamed student, the determination of the recipient shall be on the basis that all students shall have an equal opportunity to qualify for it and shall not be denied its receipt on the basis of race, color, national origin, creed, religion, marital status, gender, age, disability, military status, genetic predisposition, carrier status or sexual orientation.

Any gift rejected by the Board of Education shall be returned to the donor or his/her estate within 60 days together with a statement indicating the reasons for the rejection of such gift. All donations made to the District are not refundable.

**Draft Policy #5605, Voter Registration for Students** 

#### **VOTER REGISTRATION FOR STUDENTS**

The Board of Education believes that getting young people involved in the election process helps to secure the future of democracy by preparing young people to be educated, engaged voters who have formed the habit of voting and contributing to civic life early.

In an effort to promote student voter registration, the Board directs the Superintendent or his/her designee to offer all students who are at least 16 years old (but will not be 18 years old by the next election) the opportunity to register. These students must be otherwise qualified to register to vote. These pre-registrations will be automatically registered upon reaching the age of eligibility following verification of the person's qualifications and address.

The district will do so by offering registration materials through homeroom/other required classes at different times during the year.

Students who do not wish to pre-register to vote do not have to do so. There will be no penalty (including participation grades or credits) for choosing not to do so.
