Pledge of Allegiance

Meeting called to order at 6:00 p.m. by Mr. Goldberg, President of the Board of Education. In accordance with Governor Cuomo's Executive Order related to temporary modifications to Public Officers Law, the meeting was conducted in a virtual format to allow for the uninterrupted continuation of our important work. The Board meeting notice indicated that access to the meeting would be posted on the district's website at www.farmingdaleschools.org and a live feed would be available on www.youtube.com.

Motion made by Mrs. D'Amico, seconded by Mrs. Soete, to meet in executive session to discuss specific personnel matters in accordance with Open Meetings Law. Motion carried 7-0

Meeting recessed for executive session at 6:00 p.m. Meeting reconvened in public session at 8:00 p.m. Board President Michael Goldberg opened the meeting with the following statement:

Pursuant to Executive Order 202.1 (and subsequent orders closing District schools) issued by the Hon. Andrew M. Cuomo, Governor of the State of New York, signed March 12, 2020, and due to the concerns of the Board of Education for the Health and Safety of the community emanating from the current COVID-19 pandemic, there would be no in-person public access to the board meeting and instead the meeting would be live streamed and recorded. Access to the live stream could be had by accessing the school district's website for a link that will bring you to a youtube site and the recording of the meeting can be accessed on www.farmingdaleschools.org. In addition, the public participation portion of the meeting was suspended by board resolution.

On a motion made by Mrs. D'Amico, seconded by Mr. Espinosa, pursuant to the aforementioned Executive Order, the Board suspended the public participation portion of the meeting and therefore, accordingly, there would be no public participation at this Board meeting.

Mr. Goldberg continued, stating that the Board of Education was interested in encouraging members of the public to share their ideas, comments and questions. Feedback and questions should be directed to the Board's email account at boe@farmingdaleschools.org. Questions and comments would be responded to by members of the central administrative team and would be publicly reviewed at the next regular Board meeting. Mr. Goldberg thanked everyone for their anticipated courtesy and cooperation. The meeting began with the Pledge of Allegiance.

Superintendent's Update

Monthly Update

Board President Michael Goldberg introduced Superintendent of School Paul Defendini and asked for his monthly update. Mr. Defendini began with a review of the work that had focused the district administrative team as we headed into the reopening of school. He stated that the physical issues associated with the new normal of the delivery of instruction was paramount: setting up classrooms with appropriate social distancing protocols; addressing transportation systems; reviewing food service delivery options; setting up arrival procedures and training staff for temperature and questionnaire methodologies. He stated that the new environment is creating opportunities and challenges; some students are attending school in person, while others prefer to remain in a remote environment. Teachers are adjusting their practices to meet the needs of their charges. He stated that it has not been easy; there are some bumps in the road but that Wednesday, the second day of school for students, felt better than Tuesday and the hope is that we will build on the successes of the day before. Mr. Defendini thanked and congratulated the many employees who have been part of this reimagining of the school system. He stated that he was extraordinarily proud of all members of the Farmingdale Family as we move into this new chapter of 2020. Most important of all, Mr. Defendini stated that it was truly heartwarming to see the students in the buildings again. Board President Michael Goldberg thanked everyone for their part in this tremendous effort.

WHEREAS, as a result of the Covid-19 pandemic, such employees were required to work during spring and/or other recess periods during the 2019/2020 school year; and

WHEREAS, as a result of the Covid-19 pandemic and the State's directive to file plans for the reopening of schools, the Superintendent of Schools may request such employees to work on days during July and August 2020 in preparation for the reopening of schools, which may conflict with their previously scheduled and approved vacation days; and

WHEREAS, the Board of Education wishes to address the terms and conditions of employment of such employees on a temporary basis related to being required to work during spring and/or other recess periods during the 2019/2020 school year and for working on their vacation days during July and August 2020; and

NOW, THEREFORE, BE IT RESOLVED, for the 2020-2021 school year only, Assistant Superintendents and Assistants to the Superintendent shall be provided with seven (7) additional days of vacation which they may use at any time prior to June 30, 2021, upon prior approval of the Superintendent of Schools. They shall not be compensated for any unused vacation days. Vacation days not used by June 30, 2021 shall be forfeited.

BE IT FURTHER RESOLVED, that in the event the Superintendent of Schools or his designee requests that a Assistant Superintendent or Assistant to the Superintendent work on a day during the period from July 1, 2020 up through and
